AFFECT, Inc. Summer Camp

The mission of the Avenue F Family Enrichment Corporation of Texas (AFFECT, Inc.) Summer Camp is to provide a safe, nurturing environment where kids can learn and grow, academically, physically, and spiritually to better prepare program participants to be ready to enter the Fall school year, by bridging the gap over the summer months.

Program participants will do the following:

- Complete the required reading – a minimum of two age-appropriate books per week
- Complete academic exercises daily
- Participate in physical activities daily
- Prepare their minds to be ready for the next school year
- Maintain appropriate discipline and follow instructions

... all while having FUN!!

Volunteers are expected to help achieve the overall mission of AFFECT, Inc. by assisting with:

- Tutoring and mentoring the program participants in various school subjects
- Encouraging and providing support for the sports and other physical activities
- Assist with transporting the participants between the host location and off-site activities.
- Ensure participants are checked in and out appropriately each day
- Keeping the participants on task and on schedule
- Providing additional support and recommendations, as needed

Volunteers are expected to report to the building at least 30 minutes before the scheduled activity is to begin. Volunteers are requested to call the main number, if you are not present at least 15 minutes before your scheduled time. Schedules may vary slightly each day, as we begin to develop a routine. We ask that you remain flexible and willing to assist in any capacity to ensure the program participants are able to achieve the goals of the program.

Volunteers should record their hours each day and submit the hours at the end of each week. AFFECT, Inc. would like to keep record of this information to assist with future plans to seek State and Federal funds to support our future tutoring, mentoring and camp activities. Your assistance with keeping your time records up-to-date will greatly support us and will help demonstrate our processes and procedures to prospective grantors. We hope to be able to increase our community outreach by increasing our ability and acting as an example for other nonprofit organizations. We thank you in advance for your cooperation.

Participant Liability Release/Volunteer Agreement Form

Commitment

I have been informed about the AFFECT, Inc. Summer Camp and wish to be a volunteer. I promise to participate throughout the project and will uphold my part of the volunteer responsibilities. I understand that as member of the volunteer team that I am a representative of AFFECT, Inc. and will do my best to maintain the behavior which is exhibited in the organization's Mission, Vision, and Values Statement.

Confidentiality

I promise to maintain the dignity of the program participants, including respect for their privacy, property, family and friends. I will honor the mutually agree upon boundaries of time, information and physical contact. I will hold confidential, within the volunteer team and staff, all matters discussed and issues addressed in our volunteering mentor/tutor relationship, except in those cases where the program participant gives specific release of information permission. Any act or action that can be considered questionable or of concern, will be reported to a Principal of AFFECT, Inc., as required. I understand that the limits of confidentiality, however, include that by law I must immediately report to the appropriate civil authorities, through a Principal of AFFECT, Inc. any possible involvement of child abuse, confession of a felony (serious property or physical injury) offense, the intention to do bodily harm to another person, or the intention to commit suicide.

Disclosure

My signature below indicates, in lieu of a background check, that I certify that I have a clear record, which is exempt from any criminal activity/offense against a minor, intention of physical harm or injury or intention to do bodily harm to anyone within my care, especially a minor child, within the last 10 (ten) years.

Waiver

I understand that I am personally responsible for fulfilling this agreement. LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
